

Post Offices of Central and Northern Alberta.

Continuing in our series of historical looks at post offices in Central and Northern Alberta, for this issue, we look at the Edmonton Post Office as seen in 1948. The article below is an excerpt from an article in the Post Office magazine – Postmark- dated 1948.

Edmonton

Gateway To The North - Crossroads Of The World


It seems incredible when considering the place which Edmonton holds in our scheme of national and international communication that a mere seventy-two years ago when Postal Service was first established there it was a small community which consisted chiefly of traders, trappers, missionaries, a few settlers and the Royal Northwest Mounted' Police.

At the present time, Edmonton is a key point on the Trans-Canada Air Mail network. From it radiate the Edmonton, Whitehorse, Fairbanks A.M.S., stretching through the northern areas of Alberta and British Columbia to Alaska. Northward the famous *CAM 57* carries air mail, ordinary first class mail, parcels and newspapers, together with supplies to the vast area served along the Mackenzie River, Great Bear Lake and Lake Athabaska Districts, serving such points as Fort Smith, Fort Resolution, the mining region at Yellowknife[•], Fort Simpson, Fort Norman, Norman Wells, Aklavik and the Coppermine on the Arctic shores.

From Edmonton, Railway Mail Services and motor services radiate in every direction. Geographically, Edmonton is equidistant between Vancouver and Winnipeg, and is also the starting point of the famous Alaska Highway. None need be reminded of the strategic importance which the city assumed during war days on the lines of communication by road and by air to the far Northwest and to Alaska.

The city has earned its soubriquet "Gateway To The North" because from the first it has been the "jumping-off" place and distributing centre of all the area which we now know as the Northwest Territories and the Yukon.

The Northwest Territories alone occupy an area of 1,300,000 square miles, or nearly one third of the area of Canada. This vast northern region has received its mail through Edmonton from the days when it was carried by courier and dog team in winter, by canoe, and later by steamboat in the open season, until the present when the mail planes wing north serving the settlements and newly opened mining areas far within the Arctic Circle.



Paradoxically, Edmonton, while one of our new cities, has long held a position on the map of Canada. It was founded as a trading post in 1807.

At the time the Post Office was opened on August I, 1876, a mail service was established between Winnipeg and Edmonton, a distance of about 900 miles, serving five intermediate offices. The one-way trip was performed by stage over "the Edmonton Trail" in about 21 days.

As the C.P.R. continued to move westward from Winnipeg, the mails were carried to the end of steel and thence transported by wagon. By 1882, the mails were carried from Troy (Qu'Appelle Station), 323 miles west of Winnipeg, to Edmonton, a distance of 584 miles, the one-way trip being about 15 days.

The city's modern postal service dates from the completion of the C.P.R. railway. between Calgary and Edmonton in 1891. From this period, the mails were carried by railway to the terminus of this long stage route.

There was a further improvement in service when the main line C.N.R. reached Edmonton in 1907. In the same year, the first Post Office was established at Fort Smith in the Northwest Territories, and was served through Edmonton, and by 1910 regular postal service was being given to numerous far northern points.

A memorable year in the postal development of the northland was 1929, when the first mail carried by air, north from Edmonton reached Aklavik at the mouth of the Mackenzie close to the Arctic Ocean.

Speaking generally of the growth of air transportation into the hinterland, it is not commonly known that in 1937 (before the war put a temporary curb on mining activity) more air tonnage was flown north from Edmonton than the whole total carried by plane in the U.S.A.

From the modest annual revenue of \$21.71 reported for two quarters at the close of the first year of operation in 1876, the gross revenue of the Edmonton Post Office has grown to \$1,388,049 in the fiscal year 1946-47.

The departmental publication Postmark was first issued in August 1939. In December, it was suspended for the duration of the Second World War and resumed publication in May 1948. In March 1969, Postmark ceased publication.

Restructuring the Canada Post Pension Plan: - Update

PLEASE NOTE: This article applies only to Canada Post retirees that have retired after Oct 1, 2000. Those members that retired prior to Oct 2000 are on the Public Service Superannuation Plan, and are not affected by these potential changes.

In February 2014, the Government of Canada introduced regulations that provides Canada Post with relief from the need to make special payments into the Canada Post Pension Plan for four years (from 2014 to 2017). The relief is meant to provide Canada Post with a brief period to transform their business and its pension plan. Canada Post is expected to resume special payments in 2018.

We have heard many times that Canada Post is considering many options to restructure its pension plan, but after 3 years we have still heard nothing. Also, after almost 3 years, the C&C (Communications & Consultation) Group elected to help facilitate the exchange of information between the corporation and plan members, have held only 2 minuted meetings, and have sent out no updates on the subject.

Bill C-27

On October 19, 2016, the Federal Government quietly introduced Bill C-27 which is legislation to modify the Pension Benefits Standards Act (the PBSA). This long-standing act governs the workplace pension plans found in federally regulated industries such as banks, telecommunications companies, interprovincial transport companies and most, if not all, Crown Corporations, including Canada Post Corporation. The pension plans in these sectors are almost all Defined Benefit (DB) pension plans - the most desirable, because of their predictability and security. Bill C - 27 introduces the concept of 'Target Benefit' (TB) pension plans as an addition to the options currently available to employers and employees covered by the Act.

Briefly, TB plans strive for, but do not guarantee, a specific pension benefit. Under a Target Benefit plan, if investment returns are not sufficient to fund the promised level of pension, then increases may be postponed or cancelled, benefits may be reduced, and/or employee contributions may be increased.

Can Current Plans Be Converted?

The proposed changes to the PBSA permits federally-regulated employers to establish Target Benefit plans; however, to make this happen, they are required to establish a "new" plan and it does not permit the conversion of an existing Defined Benefit or Defined Contribution plans to a Target Benefit plan.

An employer, may however, provide the option for a member to consent to surrender his or

her current benefits under an existing plan in exchange for a Target Benefit. Defined benefits earned for service to date under a DB provision may only be transferred to a TBP with the consent of members, former members and survivors. Consent must be provided at an individual level, except that in a unionized workplace the union may consent on behalf of active members.

Buy-out annuity purchase

So, what might plan sponsors offer to retirees? Bill C-27 also permits DB pension plans to extinguish their liability to members through the purchase of a buy-out annuity. The annuity must be purchased from a life insurer or another issuer approved by the Superintendent of Pensions. The plan must authorize the annuity purchase and the annuity must replicate the benefits under the plan. **Summary**

Summary

First, it must be remembered that at this time, Bill C-27 is only proposed legislation. The bill is experiencing significant pushback on several fronts. It may be a long time, if ever, before the legislation is enacted, and even if approved it will likely undergo many changes from its current form.

From an employer perspective, the Target Benefit plan design — with its significant compliance costs, rigorous funding and governance requirements —may discourage many employers from pursuing the new option. However, employers such as Canada Post, with large and volatile defined benefit liabilities may continue to see it as an opportunity to change course on their future retirement obligations.

Since the federal proposals don't permit the conversion of past accrued benefits under an existing plan, it will be interesting to see whether employers like Canada Post will avail themselves of the option of seeking consent to surrender benefits under an existing DB plan in exchange for benefits under a newly established Target-Benefit plan. The ability for DB plan sponsors to extinguish liabilities through the purchase of buy-out annuities could be a very expensive undertaking, but may help federally regulated DB employers remove pension liabilities from their financial statements Those that undertake that process will certainly face significant negotiation and compliance costs, but may continue to see the benefits of shedding traditional defined benefit obligations as a worthwhile investment.


Did you Know ?

The post office was one of the first federal government departments formed after Confederation, and took over the postal service on April 1, 1868.

As the Canadian Pacific Railway stretched across the prairies in the 1880s, a railway post office, called "End of the Line", moved with it, bringing banking, money-order and mail-order facilities to the settlers. On June 28, 1886, another railway mail car left Montreal and arrived in Port Moody, BC, on July 4. It began a national mail service which was the envy of the world for 80 years.
