A POSTAL SERVICE STORY

Anne of Green Gables author, Lucy Maud Montgomery: Assistant Postmaster, Cavendish Post Office

Lucy Maud Montgomery's career in the Post Office is not widely known outside of the Maritimes, said Bianca Gendreau, Manager of the Research Division at the Canadian Museum of History, but it ultimately helped spark her illustrious career as an important Canadian author.

"She used a lot of letterheads, official documents that you use in a Post Office, she used those to write her stories and novels," said Gendreau.

"It was while working that she could send her manuscripts over to different editors without the village knowing about it. It was so important to her to retain her privacy...until she was accepted as a published author, she did not want to let all the village know this was her goal, her dream." Montgomery's writing was a secret she guarded very closely – something the author discussed in her diaries, said Gendreau.

"In those days, Cavendish was a small town and the Post Office was a place to meet, exchange news, share information and where you received information about government services," said Gendreau, adding that Montgomery started working at the Post Office in 1898.

Gendreau said the Post Office was located in a house where Montgomery lived with her grandparents. The house had been destroyed, so a similar, old house, white with green trim, was discovered and moved from elsewhere in Cavendish to the present site. Al Green, District Director in N.B. and P.E.I. at the time, was instrumental in setting it up as a working Post Office in the 1970's.

Another famous Post Office is the one at Peggy's Cove: Mick Ryan, District Director in Nova Scotia, was involved in having a Post Office incorporated in the old light house during that same time period.
