HERITAGE CLUB SCHOLARSHIP PROGRAM – 2024

The Heritage Club is planning to award three (3) scholarships to children or grand children of all dues paying members of the Heritage Club. The scholarships are valued at \$2,000 each for university or college studies. The scholarships will be awarded to students starting, for the first time, their first year of full time studies.

ELIGIBILITY CRITERIA

Dependent children, including adopted children and stepchildren, grandchildren, wards in legal guardianship of all active members (dues paying member for the last 2 years) of a Heritage Club Chapter. Applicants who have previously received a Heritage Club scholarship are not eligible.

ELIGIBLE INSTITUTIONS

These scholarships are applicable to all Canadian educational institutions which have provincial degreegranting powers or their affiliates and at Canadian colleges or CEGEPs.

QUALIFICATIONS OF APPLICANTS

Applicants must have completed the requirements for admission into the first year of an undergraduate degree program or college diploma program at a recognized educational institution. Applicants must have obtained an average of 75% (or equivalent) on the best 5 academic courses (see list of academic courses below) in the final year of secondary school or CEGEP (pre-university education). If applicants interrupt their schooling, the maximum period permitted between the completion of secondary school or CEGEP (pre-university education) and the commencement of an undergraduate university degree program or college diploma program is 1 year. During this period, students may NOT have undertaken postsecondary courses.

ACADEMIC COURSES - GRADE 12/CEGEP

Language Arts, Mathematics, Pure Mathematics, Applied Mathematics, Science, Biology, Chemistry, Physics, Social Studies, Geography, History, Literature, Accounting, Computer Graphics, Law. French, English or any one language.

SELECTION OF SCHOLARSHIP RECIPIENTS

The jury is comprised of the Heritage Club executive committee members. The evaluation will be based on scholastic ability, character and leadership qualities at school and in the community. Decisions of the jury are final and without appeal.

APPLICATION DEADLINE

Submissions must be postmarked on or before June 30, 2024.

A POSTAL SERVICE STORY

PINERIDGE CHAPTER RAILWAY MAIL CLERKS

A long time ago, actually from 1854 to 1971, the Canada Post Office, as it was called before it became a Crown Corporation, came up with an innovative way to speed up mail delivery: mail that was being shipped between two destinations would be sorted in transit, inside railway mail cars and thus, the mail would arrive almost ready for delivery to its final destination. It was the express service of the time.

This activity was performed by a class of postal clerks that were called Railway Mail Clerks. They had to be fast sorters, they had to have phenomenal memory retention and geographical knowledge for the sortation to Canadian cities, they had to be resourceful in decision-making if, for any reason, the train deviated from the planned trajectory or schedule and they had to pass exceedingly stringent exams to retain their position.

On top of a salary, they were paid one and half cents per mile. But you wouldn't get rich on this because, out of your mileage money, you had to pay your own meals and accommodations, like if you ended on a dead end run. This was why most RMCs packed their own meals, many of them slept on mail bags, laid on top of a sortation table and some of them even carried around their own mattresses!

The railway mail cars often carried valuables, but unlike their counterparts in the USA, our RMCs never packed a firearm. Good ol' Canadian trust!

Last year, the Heritage Club approached Canada Post with a proposal to finally designate a stamp in honour of the proud and selfless service that the Canadian RMCs performed. Canada Post did not say no but it is sometimes a long process to obtain a stamp.


Perhaps we need any Railway Mail Clerks still out there to write to the President of CPC asking for the recognition their group never received?

I recently had the opportunity to chat with two of my Pineridge Chapter members who were RMCs in their younger days: Ken Louden, who served mainly on the East runs and Danny Mulvihill, who served on the West. Both of these gentlemen have a wealth of knowledge about Post Office history and both had long and successful postal careers.

Ken Louden eventually became a Plant Manager in the Toronto area, and Daniel Mulvihill became National Director of Personnel in Ottawa.

Also, Daniel was instrumental in the creation of the Heritage Club under Bill Kennedy and Donald Lander.
