<u>Good to know – Tips for retirees and about-to-be's!</u>

End of Life Planning – Choose your representatives wisely

We all know by now that having a well-written will is an essential gift to those we leave behind. Equally important is our choice of those named as our representatives. For example, if you choose to sign an Advance Health Care Directive, make sure that your loved ones have a copy available to them. And choose your Substitute Decision Maker wisely — can they be easily reached when decisions need to be made? Emergencies rarely happen in "normal business hours" — more likely at 5 p.m. on the Friday before a long weekend. Emergency room doctors can't wait until the right person can be tracked down.

Are your loved ones aware of your wishes regarding funeral and burial arrangements? Stating this in your will isn't sufficient, as the will is often not available until after these decisions have to be made and implemented. Talk to the people who will be faced with making these choices.

And when you choose the executor of your will, choose carefully. Acting as executor of someone's will can be considered an honour, but it is also a big responsibility, and often comes with a considerable workload. Whoever you choose, ask them if they are willing to take it on. Then tell them if they are named. And update your will when necessary, if circumstances change and your designate is no longer available.

Remember, these end-of-life decisions will eventually have to be made, often quickly, and at the worst possible time for those involved. If we talk about these difficult subjects well in advance, and if everyone knows what is expected of them, some of the stress can be removed from the situation. Dealing with the death of a loved one is never easy, but we can make it a little less painful if we have honest conversations about the choices that will need to be made.

4 You are a target.

It's awful to think, but our very demographic makes us a lucrative target for scam artists all over the world. From "grandparent scams" to phishing emails and fraudulent text messages, the electronic world seems to be conspiring against us. And many of us, as we are just trying to grasp these new technologies, are ill-equipped to protect ourselves.

So it is doubly important that we all learn as much as we can about the tricks being used against us and that we are over-cautious about phone calls, emails, and text messages which may be targeting our naiveté. Beware of any requests, no matter how legitimate they sound, for personal or financial information, or worse still, money, that come to you by phone or email. Your first reaction must always be to doubt the authenticity of the request, refuse to provide whatever they're asking for, and step back. It's going to sound real – that's what these criminals are really good at – so just say no and disengage. Verify everything, with a phone call you place yourself to a proven contact number.

And on that note, protect yourself by limiting personal details that you share publicly. Fraudsters often use information that's available online and on social media to find potential victims and to time their fraud. The grandchild's graduation photo which is such a source of pride could also be a trigger for scam activity.

Your Benefits Survivor Procedures

To ensure the survivor of a retiree maintains pension, health and medical benefits, a number of contacts must be made immediately upon a retiree's death.

Access H.R. (1-877-807-9090) (For Active Employees)

Info required: Retiree name, employee ID #, Social Insurance number, copy of death certificate

C.P.C. Pension (1-877-480-9220)

Info required: Retiree name, employee ID#, postal code, month and date of birth, copy of death certificate, copy of retiree's will

Canada Life (1-866-716-1313)

Info required: Retiree name, employee ID# and/or Certificate #, copy of death certificate, plan number (51057 & 51391, 52111-52115). Note: Very important to notify Canada Life as soon as possible in order to set up a new automatic withdrawal in the survivor's name to keep policy in force and maintain medical, dental, and vision benefits.

C.P.P. / O.A.S. (1-800-277-9914)

Info required: Retiree name, Social Insurance number, copy of death certificate. In addition to the survivor pension, there is also a death benefit payable to the survivor.

Superannuation (if applicable) (1-800-561-7930)

Info required: Retiree name, Social Insurance Number, copy of death and marriage certificates. Upon request for coverage (within 60 days of death) Canada Life premiums for survivor may be deducted directly from survivor pension.

Canada Revenue Agency (1-800-959-8281)

CRA must be contacted when a member or spouse passes away, and T-1 and T-3 to be completed.


