<u>Clarification on the most recent Annual Statement from the Pension</u> Centre (Dec 31/24)

The wording of the latest statement regarding survivor benefits has caused some confusion and consternation amongst pensioners. It states that the survivor will receive a lifetime survivor benefit from the plan of \$XX per month, less applicable taxes. "This estimate was calculated as of your pension commencement date." Obviously this does not appear to take subsequent indexation into account. Our National President J.P. Leguerrier reached out to Canada Post for clarification and received the following reply:

Dear J. P. Leguerrier:

Thank you for your email on behalf of the Canada Post Heritage Club to Doug Ettinger, President and Chief Executive Officer, and others at Canada Post, regarding the announcement of AON as the new administrator for the defined benefits of the Canada Post pension plan, as well as the latest pension statements received. In my role as General Manager of Total Compensation, I oversee our compensation and pension teams, and as such, I was entrusted with your reply.

At the outset, I would like to thank you for voicing these concerns on behalf of the Heritage Club, and I apologize for the confusion that this change may have caused some of our members. I understand our former employees rely on their Canada Post pensions, and I assure you we are committed to providing accurate and transparent information throughout these changes.

I understand many of our Heritage Club members voiced similar concerns about Canada Post's survivor benefits. I would like to reiterate that, as Miriam Tanguay Simard, Manager of Pension Regulation, wrote to you on June 12, 2025, the survivor benefit has not been reduced. I can confirm that the wording on next year's annual pension plan statement will be updated to explicitly indicate that the amount shown is before indexation. Moving forward, this amount will remain unchanged, as it is based on the calculation performed at the member's retirement date. It will only be recalculated—and indexation applied—if and when the survivor benefit becomes payable following the member's death.

Thank you once again for writing. I hope I was able to provide clarification to these concerns for you and other members of the Heritage Club. Please accept my best regards.
