### Message From The President



2024 is here and we have been lulled into a false sense of comfort with the delayed arrival of a true winter along with the accompanying snow. You remember that stuff – white, cold and has to be shoveled, etc. On the other hand the ski community is jumping for joy. The C.P.I. numbers indicate a trend of approximately 3.1% for 2025 indexing. There is a rebranding of the familiar Johnson Insurance divisions into Belair Direct. This will be covered off later in the Newsletter. The next change is much more extensive and time consuming. It involves the migration of Sun Life covered members (primarly Superannuation recipients) to Canada Life. There are enrolment forms to complete as well as direct deposit documentation. These forms are now available from your Heritage Club – contact us.

We will continue to meet with up & coming retirees to prepare them for their receipt of documentation related to retirement and review of important documents they will have to complete for the process such as divorce agreements from any previous marriages. It is time for a reminder to any members who have not already done so, that membership dues are to be paid for 2024. These dues help fund your Heritage Club and allow events and services to continue. If you are unsure if you have already paid your 2024 membership dues, just give us

a call. There has been a substantial increase in the number of soon-to-be retirees seeking out the Heritage Club for pre-retirement assistance with what to expect in the way of forms and documentation surrounding the retirement process. There has also been a notable increase in the number of widows and widowers requesting help with documentation regarding survivor pensions, life insurance and continuation of survivor benefits.

The Columbia Sportswear Employee Store Invite is back again and is open from March 15, 2024 to April 14, 2024 for members from any Chapter. We are here for you, our supportive members, and will continue being here for you.

#### Heritage Club Support To Members

#### Widows / Widowers

There is a need for widows / widowers of former Canada Post employees to have help when facing the death of a spouse when it comes to pension , benefits and survivor documentation.

There were twenty four (24) consultations held in 2023 and 7 so far in 2024 with widows and widowers to assist them with C.P.C. survivor benefits, Superannuation pension questions and PSHCP impact as well as completion of various documentation including the Basic and Over-65 Life Insurances and Supplementary Death Benefit from Superannuation. Also, we have guided widows / widowers when dealing with funeral homes as to the assistance these homes can provide with documentation to ensure that C.P.P. death benefit and survivor pension is applied for and submitted.

#### **Pre-retirement Meetings**

Meetings are available to future retirees about what to expect in the way of documentation from Canada Post , the Pension Centre and Canada Life. Subsequent meetings can also be held with these retirees to assist them with completion of these forms including witness signatures.

There were 36 meetings in 2023 and 3 so far in 2024 with potential retirees.

#### Your Postal Spouse Passes Away – Now What Do You Do?

### **Initial Steps**

- 1. Contact your Funeral Home and check with them to find out if they'll take care of the C.P.P. applications for survivor pension and the death benefit. If not, you may have to get a set of the forms and complete them yourself and send them in. Your Thames Heritage Club has a supply of both C.P.P. application types. (Survivor Pension & Death Benefit)
- 2. Contact your bank and open an "Estate Account". This will be important to you as the death benefit payment from C.P.P. will be made out to the estate of the deceased. Also the process takes the bank some time to set up and can be done while you are dealing with other matters.
- 3. This step is a two (2) part process depending on the source of the pension of the deceased.

Superannuation (Gov't of Canada Pension Services) Shediac, NB 1-800-561-7930

If the deceased received their monthly pension from this source, then the survivor pension will also come from here. They are to be contacted and notified of the death of the retiree. They will inform the survivor of what information is required and will send out the forms. They will also take care of the Sun Life Dental Benefits and the Supplementary Death Benefit.

Canada Post Pension Centre

Mississauga, ON 1-877-480-9220

If the deceased received their monthly pension from this source, then the survivor pension will also come from here. They are to be contacted and notified of the death of the retiree. They will inform the survivor of what information is required and will send out the forms. This pension centre also deals with death benefit and beneficiary documents.

4. Canada Life

Winnipeg, MB 1-866-716-1313

This is the centre for establishment of survivor health and dental benefits for survivors of Canada Post retirees who receive their pension from the Canada Post Pension Centre in Mississauga.. There are a set of forms to be completed to assist Canada Life to set this up.

NOTE: - Your Thames Heritage Club can assist you with any the above processes.
