Our vision

The Canada Post Community Foundation's vision is to ensure every child in Canada is happy, healthy and surrounded by a caring community.

How does the Canada Post Community Foundation help children?

The Canada Post Community Foundation is dedicated to improving the lives of children by building the capacity of local registered charities, initiatives and school programs that support them. Whether it's through increasing access to healthy food, libraries and play areas, enhancing support for special needs and education, or aiding the recovery from abuse, neglect or conflict, the Foundation believes that a strong community connection helps develop happy, healthy and resilient children.

How does the Foundation differ from Canada Post?

The Canada Post Community Foundation is a registered not-for-profit Foundation, operated at arm's length from Canada Post, with an independent board of trustees. Its audited financial statements are available to the public. More than 92 per cent of all donations received by the Foundation are used to fund community-based organizations. Once a year, through an open, criteria-based granting program, it distributes funds raised by Canada Post.

How does the Foundation work?

The Canada Post Community Foundation's grants are distributed to community groups, offering direct support to programs, initiatives and activities that benefit children. The granting process takes place each spring, when registered charities, schools and community organizations are encouraged to apply for a portion of the funds available.
